Cancellation/substitution: provided the total fee has been paid, substitutions are at an extra charge up to 14 days before the event. Substitutions between 14 days and the date of the event will be allowed subject to an administrative fee of 10% of the total fee. Otherwise all bookings carry 50% cancellation liability immediately after signed sales contract has been received by Mwanzoni Limited (as defined above). Cancellation must be received in writing by mail 1 weeks before the training is held to obtain a full credit for any future Mwanzoni Limited training.
